1. THESIS CONTENT

The contents and details that should be included in the thesis are as follows:

1.1. Cover page

The cover page should include the name of the program, the thesis title, the student's name and surname, the thesis advisor and, if any, the title and name of the co-advisor. An example of the cover page is given in Appendix 1.

1.2. Jury Approval Page

This is the page where the information of title, name and university of thesis defense jury members are included. An example of the jury page is given in Appendix 2.

1.3. Abstract

It is the page where the English summary and keywords of the thesis study are included. The title of the thesis, the name and surname of the student, the name and surname of the advisor and, if any, second advisor, abstract, keywords should be written in order. An example of an abstract page is given in Appendix 3.

1.4. Öz (Turkish Summary)

This is the page where the Turkish summary and keywords of the thesis study are included. The title of the thesis, the name and surname of the student, the name and surname of the advisor and, if any, second advisor, abstract, keywords should be written in order. An example of the abstract page is given in Appendix 4.

1.5. Acknowledgements

Acknowledgments must be added at the final thesis submission stage after the thesis defense is successfully completed. Acknowledgment page is given in Appendix 5.

1.6. Text of the Oath

It is a page consisting of the student's name, surname and date, with an article stating that the thesis study was written without resorting to any help that would be contrary

to scientific morals and traditions, and that the works benefited from consisted of those shown in the bibliography and that they were used by referring to them. Sample text is given in Appendix 6.

1.7. Table of Contents

The chapters and all titles of the thesis study and the content page numbers are given on this page.

1.8. List of Figures

The figures used in the thesis and the numbers of the pages containing the figures should be written as a list. Sample figures list page is given in Appendix 7.

1.9. List of Tables

The tables used in the thesis and the numbers of the pages containing the tables should be written as a list. Sample tables list page is given in Appendix 8.

1.10. Symbols and Abbreviations

The explanation of the symbols and abbreviations used in the thesis should be on this page. Example page is given in Appendix 9.

1.11. Research Chapters

Thesis study chapters and thesis content should be included in this section.

1.12. References

The sources used for the thesis study should be written on this page in accordance with the reference format and in alphabetical order. Necessary explanations for in-text citation and preparation of bibliography list are given in Section 6.

1.13. Appendices

If there are materials used in the thesis but not included in the content, the relevant content should be given on the page after the bibliography. If there is more than one appendices, each appendix should be displayed on the new page.

2. PAGE STYLE AND RULES

Theses prepared within the scope of Yaşar University Graduate School programs must comply with the page format and rules given below.

2.1. Page Style

- The thesis should be prepared according to A4 paper size.
- "Portrait" orientation should be used for all pages. Only if needed, the “landscape” orientation can be used for attachments.
- The cover page should be on the right page.

The margins for the cover page should be as follows:

- Left space: 4 cm
 - Right space: 2.5 cm
 - Bottom space: 2.5 cm
 - Top space: 5 cm
- Front pages (jury approval page, abstract, acknowledgments, text of oath, table of contents, list of figures, list of tables, symbols and abbreviations) should only be on the right page and one side of the page should be used.

The margins for the front pages should be as follows:

- Left space: 4 cm
 - Right space: 2.5 cm
 - Bottom space: 2.5 cm
 - Top space: 2.5 cm
- Front pages start with Roman page number “iii” and continue with odd page numbers only. Page numbers should be located in the bottom center of the page.
 - The thesis consists of research chapters, chapter titles and content. Each chapter starts on the right page and the content should be written on both sides.

Margins for research sections should be as follows:

Right Page:

- Left space: 4 cm
- Right space: 2.5 cm
- Bottom space: 2.5 cm
- Top space: 2.5 cm

Left Page:

- Left space: 2.5 cm
- Right space: 4 cm
- Bottom space: 2.5 cm
- Top space: 2.5 cm
- The research chapters start from “1” with the Arabic page number and the page numbers are written on both sides. Page numbers should be located in the bottom center of the page.
- The bibliography should start on the right page. The margins for the bibliography are the same as for the research sections.
 - Indentation_Custom: Hanging_0.8 cm
 - Spacing:
 - Before:0 pt
 - After 7 pt
 - Line spacing: Multiple_1,2
- For appendices pages, each new appendix must start on the right page. Margins for appendices written in portrait orientation are the same as for research sections. The margins for the appendices given in the landscape orientation should be as follows:

Right Page:

- Left space: 2.5 cm
- Right space: 2.5 cm
- Bottom space: 2.5 cm
- Top space: 4 cm

Left Page:

- Left space: 2.5 cm
- Right space: 2.5 cm
- Bottom space: 4 cm
- Top space: 2.5 cm
- Thesis font should be Times New Roman and the font size should be 12 points.
- Line spacing: 1.5 lines
- Paragraph spacing: Before: 6 pt, After: 6 pt
- Paragraph indent: None

- Paragraph layout: Justified
- Statistical symbols expressed in letters in the text are given in italics.

2.2. In-Text Headings

Heading in the text should be formatted with the following system:

- Must be all capital letters and bold.
- Times New Roman
- 13 points
- It should be aligned in the middle.
- Line spacing:
 - 1.5 lines
 - Before: 72 pt
 - After: 18 pt
- Indentation:
 - Left: 0 cm
 - Right: 0 cm
 - Special: none

3.1. Second Level Title

- The first letters of the words must be capitalized and all bold.
- Times New Roman
- 13 points
- It should be left aligned.
- Line spacing:
 - 1.5 lines
 - Before: 12 pt
 - After: 8 pt

- Indentation:
 - Left: 0 cm
 - Right: 0 cm
 - Special: none

3.1.1. Third Level Title

- The first letters of the words must be capitalized and all bold.
- Times New Roman
- 12 points
- It should be left aligned.
- Line spacing:
 - 1.5 lines
 - Before: 12 pt
 - After: 8 pt
- Indentation:
 - Left: 0 cm
 - Right: 0 cm
 - Special: First line 0.3 cm

3.1.1.1 Fourth level title and other level titles

- All should be small letters except first letter of the first word and all bold.
- Times New Roman
- 12 points
- It should be left aligned.
- Line spacing:
 - Single line
 - Before: 8 pt
 - After: 0 pt
- Indentation:
 - Left: 0.6 cm
 - Right: 0 cm
 - Special: none

4. TABLES AND FIGURES

4.1. Figures

“Figure” is the flow chart, graphic, map, photograph, drawing, etc. used in the study and its appendices which containing all visual materials.

Figure number and title are written below the figure, centered in Times New Roman 12 points. Figures are numbered in the second heading style starting with the chapter number, and the word Figure and its number are written in bold.

- Line spacing:
 - Single line
 - Before: 6 pt
 - After: 18 pt
 - Special: none

The source is written under the figure and in accordance with the citation method used throughout the thesis.

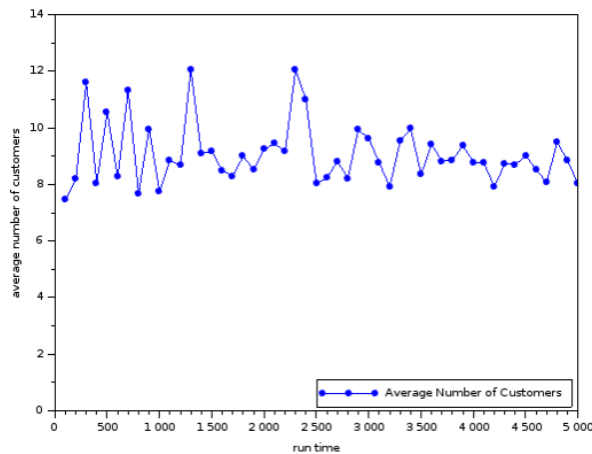


Figure 4.1. Average Number of Customers

4.2. Tables

The table number and title are written above the table, centered in Times New Roman 12 points. Tables are numbered in the second heading style starting with the chapter number, and the word Table and its number are written in bold. The source of the data

used in the tables is indicated centered at the bottom of the table. When writing the title of the table, the first letter of each word is capitalized. Line spacing:

- Single line
- Before: 18 pt
- After: 6 pt
- Special: none

References are cited in accordance with the citation method used throughout the thesis. Table content is written in Times New Roman, font size 10-12, with 1.5 line spacing.

Equations should be numbered right-aligned. Font size should be 12 points. Equations and formulas should be written using equation tools. Line spacing:

- 1.5 lines
- Before: 6 pt
- After: 6 pt
- Example equation writing is given below:

6. CITATION STYLES AND REFERENCE METHODS

The thesis must be written in one of the two formats suitable for the related Department. The first is the American Psychological Association (APA) format, and the second is the Chicago Notes and Bibliography system.

6.1. APA Method

For any information that does not belong to the author in the thesis, the author has to indicate the source cited. For the information and data transferred by the author from his previous studies, the source should be cited by referring to the previous publication. Every publication mentioned in the content of the thesis should be included in the references section.

In order to facilitate the application of the APA style, which should be used in the references and citation sections of the theses, you can examine the alternative suggestions below.

- 1- Mendeley offers a service that provides automatic bibliography transfer free of charge. You can automatically prepare your references in the desired format by using the program after the membership process from the link <https://www.mendeley.com/>.
- 2- All the features of the APA format from <http://www.apastyle.org/> or by getting one of the APA format spelling guides.
- 3- It has an automatic bibliography creation feature for the theses to be written using Microsoft Office Word. - When used for the first time in the cited source text, all information about the source is included in the footnote. In this method, when the same source is cited for the second time, abbreviations such as m.w (mentioned work) and m.a. (mentioned article) should not be used.

7. REQUIREMENTS FOR THE THESIS DELIVERY

The student should make the thesis study in accordance with the requirements of Yaşar University Graduate School Thesis Writing Guide. The thesis must be submitted to the Graduate School within one month from the date of the thesis defense. The Administrative Board of Graduate School may extend the delivery period for a maximum of one month upon request.

The thesis should be printed in 3 copies with a white cardboard cover and hardcover (without spiral). **One copy** should include the thesis approval page **signed** by the members of the jury. The other **two copies** must contain the thesis approval page, **unsigned**. All front pages up to the chapters of the work should be printed as a single page. It should be printed as right-left pages in terms of sections.

7.1. Documents to be submitted with the printed thesis

The “thesis data entry form” must be filled in and delivered to the Graduate School after being printed out from the Council of Higher Education Thesis Center (<https://tez.yok.gov.tr/UlusalTezMerkezi/>).

The thesis study should be named in PDF format with the YÖK thesis data entry reference number and loaded into 3 CDs. It should not contain any personal data (such as signature, address, e-mail address, date of birth, place of birth).
